

Purpose	This schedule will support the delivery of a Health Information Exchange Feasibility study . This will explore the feasibility of expanding the current Territory Kidney Care (TKC) data exchange project and incorporating it into existing Northern Territory health information architecture. The project will investigate how to link, integrate and share health data and information between clinicians and across sectors in the NT to deliver patient-centred integrated care. The data sharing learnings will be applicable to a broad range of chronic conditions across jurisdictions.


